Dr Deborah Luepnitz: Clinical Faculty, Department of Psychiatry at the University of Pennsylvania School of



Medicine. Deborah is the author of 'The Family Interpreted: Psychoanalysis, Feminism, and Family Therapy' (Basic Books, 1988), and 'Schopenhauer's Porcupines: Intimacy and Its Dilemmas' (Basic Books, 2002) that demonstrates her use of Winnicott and Lacan in clinical practice; and contributing author to the 'Cambridge Companion to Lacan' (2003). She maintains a private practice and consults to a shelter for mentally ill homeless women.

Dream interpretation is a stunningly effective, curiously underutilised technique in the treatment of couples and families. This lecture will begin with a review of various western interpretive methods and then describe the presenter's use of dream work with couples. Dr. Luepnitz has found that an impasse in treatment can often be broached with an appeal to dreams which function as an analytic "third," providing respite from compulsive conflict and insight into the dreamer's contribution to the deadlock. Working at this level doesn't preclude problem-solving about everyday life. The art of psychotherapy involves moving between the "upper" and "lower" worlds propitiously. But in a culture which in many ways deplores depth, attending to dreams can be the best way that intimate partners can glimpse the other's inner life.

Tjanara Goreng Goreng: Founder and Convenor, Foundation for Indigenous Trauma Recovery; Director, Commonwealth State Strategy, Office of Indigenous Policy Coordination.

"Essence and Spirit of Indigenous Culture and Spirituality"

The address will focus on the essence of Indigenous Culture and Spirituality. It will address history, traditions, the psychology of Indigenous knowledge and its use in the governance and community structures of Indigenous life. The general focus of the talk will be on how the

reviving of spirituality, culture and lore/law in everyday life for Indigenous people will affect their wellbeing and recovery from acculturation (adapting to a majority culture to survive). The author will show how traditionally indigenous Australians balanced their lives, emotionally, mentally, physically and spiritually so that peace, harmony and contentment were part of the daily life. She will also discuss how traditional cultural law and practice and governance was based in law and spirituality and allowed people to live in harmony with each other and with nature. The implications of this for counselling and psychotherapy will be elaborated.

"Self and other after nine eleven. Challenges to therapeutic assumptions"

I want to argue that underlying most of our clients' presenting problems are struggles with nurturing and being nurtured, difficulties with feelings of personal and social equality, and anxieties about personal freedom. I wish to explore these universal tensions in the context of the

response of our Australian, American and British leaders to the perceived global threats coming from "the other" since the destruction of the World Trade Centre. I want to invite therapists and counsellors to consider whether our clients are expressing or contextualising their concerns differently since nine eleven, and whether our practice as professionals has altered? If therapy has an essence, does it transcend "global change"? If practice has spirit, should that spirit challenge, ignore or accommodate to the world we are creating post September 2001?

Workshops

Thursday 24th August 2006

Aboriginal Law, Spirituality and Medicine for Wellbeing

Tjanara Goreng Goreng: Founder and Convenor, Foundation for Indigenous Trauma Recovery; Director, Commonwealth State Strategy, Office of Indigenous Policy Coordination.

This full day workshop will introduce participants through song, music, dance and ceremony to Aboriginal law, spirituality and medicine practice which supports wellbeing. Non-Indigenous cultures can learn much from the practice of law and spirituality in Aboriginal lives and this will be conveyed through the workshop in dialogue, interaction and practice. Tjanara will lead participants through a day of 'living and being' Indigenous and introduce people to skills which can be used to support Indigenous people in counseling and psychotherapy situations.

As a traditional medicine practitioner Tjanara will also demonstrate healing modalities and teach those present a simple technique of medicine for personal wellbeing. The workshop will end with a smoking ceremony for purification.

Child Sensitive Practices at the Time of Family Transition

Lawrie Moloney: Author, lecturer, former Director of Counselling at the Family Court and Co-director of "Children in Focus" a program aimed at assisting high conflict families devise solutions in the interests of their children.

In Australia, approximately one in twelve children in the general population will at some time present with a mental health problem. Amongst the *divorcing* population, however, we know that this ratio increases to one in four.

We know that this dramatic increase in child mental illness rates is not caused by the separation or divorce itself but by a failure to manage the pre and post separation conflict.

For a variety of reasons, many therapists and counsellors who are consulted pre or post separation and divorce either lose sight of the children or, if they focus on children's needs, struggle to include one or both parents within such a child centered perspective.

This workshop will discuss and demonstrate child focused practices and child inclusive practices in the context of family separation and divorce. At the end of this workshop, counsellors and therapists will be in a position to make an informed decision about whether to engage directly in this work, or to make a referral. The workshop will cover how to make appropriate referrals and consider how the work of the therapist or counsellor can support that of the child focused or child inclusive practitioner.

The PACFA Board invites all conference delegates to join us on Friday 25th August at 5pm for the Inaugural Psychotherapy in Australia Annual Writers Awards.


