ROLE SUMMARY

PACFA has a proud history of leading the way for counselling and psychotherapy registration and accreditation in Australia. This role will enable PACFA to enhance its service and support for training organisations nationally, as well as ensure that the highest standards are encouraged for the important work of counselling and psychotherapy training.

The Head of Accreditation will lead the work of PACFA volunteers and staff to deliver PACFA's course accreditation services and the implementation of a continuous improvement culture.

In a small supportive organisation this is a hands-on role for a dynamic individual to enhance and develop processes and create meaningful change. The position is flexible in delivery with some ongoing working from home considered for the right candidate.

MISSION

The Psychotherapy and Counselling Federation of Australia (PACFA) is a peak body for the counselling and psychotherapy profession in Australia. PACFA's mission is to advance the counselling and psychotherapy profession and to benefit members of the community who seek their services. In addition, PACFA is home to the College of Aboriginal and Torres Strait Islander Healing Practices.

POSITION PURPOSE

The Head of Accreditation position is responsible for both engaging educational stakeholders and ensuring the highest quality accreditation processes are executed by the organisation.

This position reports to the CEO and provides reports to the Board and attends Board meetings. The position is supported by a part-time Accreditation Co-ordinator. The role is 2 days per week on a 2 year contract, commencing early 2023.

KEY RESPONSIBILITIES

The Head of Accreditation is a leadership position for the Counselling and Psychotherapy sector who will be responsible for overseeing PACFA's accreditation work and representing the work of the organisation to the sector. Responsibilities will include:

- Leading accreditation activities of PACFA
- Overseeing work of Panels (including managing volunteers and ensuring conflicts of interest are reported and managed)
- Finalising timely reports by Panels
- Liaising with training organisations to answer queries, address issues and encourage continuous improvement as related to accreditation
- Working with the PACFA office to revise and update documentation as relates to accreditation in line with external standards including the National Alliance of Self-Regulating Health Professionals.
